Dear Parents, Guardians and Staff;

The Children's Center is committed to protecting our students' and staffs' health. We have recently completed lead testing of our water supplies.

The water testing was performed in compliance with the technical guidance developed by the New Jersey of Environmental Protection and in accordance with the New Jersey Department of Education regulations.

We are pleased to report to you that none of the results of our operable water samples taken on March 30, 2022 and/or April 14, 2022 exceeded the federal EPA action level. Every sample tested below the lead action level of 15 ug/l or PPB established by the US Environmental Protection Agency.
