Dear Parents, Guardians and Staff;

The Children's Center is committed to protecting our students' and staffs' health. We have recently completed lead testing of our water supplies.

The water testing was performed in compliance with the technical guidance developed by the New Jersey Department of Environmental Protection and in accordance with the New Jersey Department of Education regulations.

We are pleased to report to you that none of the results of our operable water samples taken on May 3, 2025 exceeded the federal EPA action level. Every sample tested below the lead action level of 15 ug/l or PPB established by the US Environmental Protection Agency.

A copy of the lab results including the cover letter reporting the results from Lyons Environmental Services, LLC are available in our central office for inspection by the public, including students, teachers, other school personnel, and parents between the hours of 8:30 a.m. and 4:00 p.m. and can also be found on our website at www.ccprograms.com.
